A meeting of Victoria County Municipal Council was held at the Court House, Baddeck, on Monday, October 29, 2018, beginning at 4:30 p.m. with Warden Bruce Morrison in the Chair.

IN CAMERA

It was moved and seconded to move In Camera to discuss personnel issues. Motion carried.

It was moved and seconded to return to the regular session of Council. Motion carried.

CALL TO ORDER/APPROVAL OF AGENDA

Warden Morrison called the meeting to order and presented the agenda for approval. He indicated he would like to add Committee review to the agenda.

It was moved and seconded that the agenda be approved with the noted addition. Motion carried.

Page 2, VICTORIA COUNTY MUNICIPAL COUNCIL, October 29, 2018

DANGEROUS AND UNSIGHTLY PREMISES

Courtesy of Council was extended to Jonathan Martin, Administrator, Dangerous and Unsightly Premises, and John Bain, Director, Eastern District Planning Commission (EDPC).

John Bain introduced Jonathan Martin to Council. He is the new Assistant Building Inspector and Administrator for the Dangerous and Unsightly Premises.

Dennis Buchanan and Brenda Billard

Jonathan Martin indicated that a building on the property assessed to Dennis Buchanan and Brenda Billard, located at 36 Tamarack Lane, Baddeck, N.S. – PID 85013811 is in a ruinous and dilapidated condition.

The property is not abandoned, but the building in question is severely neglected. The exterior is not maintained and it is open and accessible. There are several structural issues with the building. The foundation has failed and is caved in. There is no power connected to the building.

Mr. Martin presented the Certified Building Officials report, along with pictures of the premises and his recommendation as Administrator. The dwelling meets the *Municipal Government Act* definition of "dangerous and unsightly". It is recommended that an "Order to Remedy Condition" be issued and that the Order be a Demolition Order issued from Council to the owners and it be a 30 day Order that the dwelling is to be demolished and all debris be removed and disposed of in the appropriate manner. If the property owners fail to comply, the Municipality will complete the work and recover costs.

The property owners have been notified of the proposed demolition by 2 Registered Letters which have not been picked up and the building was posted with a demolition letter on October 15, 2018.

Warden Morrison questioned whether there was any representation for the owners in attendance. The owners or their representative were not in attendance.

It was moved and seconded that an "Order to Remedy Condition" be issued and that Order be a Demolition Order issued by Council to Dennis Buchanan and Brenda

Billard and it be a 30 day Order that the dwelling be demolished and all debris be removed and disposed of in the appropriate manner. Motion carried.

Warden Morrison extended a thank you to Jonathan Martin and John Bain for their attendance.

<u>APPROVAL OF MINUTES – OCTOBER 15, 2018</u>

The minutes of the October 15, 2018, meeting of Victoria County Municipal Council were presented for approval.

It was moved and seconded that the Victoria County Municipal Council minutes of October 15, 2018, be approved as presented. Motion carried.

OLD BUSINESS

Approval was received from both the EDPC and the Department of Transportation and Infrastructure to rename private road 6106, Baddeck Bay, to Lighthouse Lane.

It was moved and seconded that Council approve the private road name of Lighthouse Lane, Baddeck Bay. Motion carried.

Warden Morrison advised that Councillor Perla MacLeod was absent due to illness and Council wished her well and hoped to see her return to the next Council meeting.

Leanne MacEachen updated on the Family Physician Forum to be held in Toronto in November. She and Warden Morrison met with Lisa Hardy, NSHA, on this matter. An application has been made for a Victoria County booth at the Forum and representatives have been contacted from both areas of the Municipality to man the booth. Promotional materials are being compiled for the booth and the possibility of having a draw at the booth was discussed.

NEW BUSINESS

A road name petition was received to name a private road in Ingonish Centre as Stuart's Lane.

It was moved and seconded that the petition be forwarded to the EDPC and Department of TIR for approval. Motion carried.

Leanne MacEachen advised that a new collection truck was put into service this week and a used truck has been sold to Inverness County.

The CAO advised that there is now 7 day coverage for the water utilities in the northern area of the County.

Deputy Warden Dauphinee questioned whether the fire hydrant before the toll gate in the Cape Breton Highlands National Park was repaired. This will be investigated.

It was moved and seconded that the recommendations from the Committee of the Whole and the In Camera meetings be approved. Motion carried.

TAXATION UPDATE

Taxes owing this year are down approximately \$84,000.00 - from \$2.393 million last year to \$2.3 million this year. This is not as far ahead as we would like to be. Reminder notices have gone out in the mail.

The CFO is developing a spreadsheet that the Tax Department will use to highlight the taxes owing, arrangements and allow for notes. This will help in many ways.

Warden Morrison announced that Council would recess for 10 minutes.

COMPLIANCE PROGRAM UPDATE

An update was provided on the solid waste compliance program. 70 bags were tagged and not collected this week. The CAO outlined the numbers per collection day, except for Monday as the tags were not received prior to that day.

It was moved and seconded that \$200.00 be approved from the District #8 budget for the Alex Capstick Manor for a seniors' social. Motion carried.

The water survey in the Cape North/South Ridge Road has been completed and a meeting will be held at the Cape North Cultural Centre on Friday, November 2, 2018, at 6:00 p.m. to outline the results.

District #6

Deputy Warden Dauphinee questioned if a reply was receive to the application for transit.

The CAO read a letter from Hon. Leo Glavine, advising that he has asked Greg Sewell, Manager of Municipal Operating Grants, to work with Jessie MacDonald, Strait Area Transit. A decision on the funding request will be made after this report.

Councillor Patterson questioned on the Scotia Windfield's community investment fund. This fund was received by the Baddeck Lions Club this year. There is a public application process and information on this process will be obtained.

District #3

Warden Morrison indicated that at the meeting with TIR officials on October 17, 2018, they agreed to lower the speed limit by the Irving/Tim Hortons while the construction was taking place. To date the speed signs have not be erected and the construction has begun. TIR is to be contacted in this regard.

Warden Morrison has been requested to sit on the Committee for a new library in CBRM. As Victoria County is a member of the Cape Breton Regional Library, it was felt it would be beneficial to have a presence on the Committee.
