A meeting of Victoria County Municipal Council was held at the Highland Village in Iona on November 28, 2022, at 2:00pm with Warden Morrison in the Chair.

Warden Morrison welcomed everyone and acknowledged that this meeting is being held in Unama'ki, one of seven traditional districts of Mi'kma'ki, the ancestral and unceded territory of the Mi'kmaw People.

CALL TO ORDER

Warden Morrison called the meeting to order and presented the agenda for approval and made note that Vince MacLean would be presenting first, then Rodney Chaisson.

On Motion of Councillor Longva, seconded by Councillor Organ that the Agenda for November 28, 2022, be approved with the noted change.

Warden Morrison acknowledged that Ross MacDonald, from Municipal Affairs was in attendance.

<u>CAPE BRETON COMMUNITY VENTURES PRESENTAION – VINCE MACLEAN</u>

Mr. MacLean gave a brief overview and presentation of Central Cape Breton Community Ventures.

Mr. MacLean is a volunteer and is speaking on the Ventures behalf. The group started in 1999. Its mission was to enhance the social and economic development of central Cape Breton.

The wharf in Iona was a major area of focus for this group. They see the Bras d'Or Lakes as a microcosm with the local wharfs.

In 2016 the Venture began with Ocean State, it is a federal program along with cooperation and recognition with the UN and that is why we celebrate World's Ocean's Day every year.

There is a weather station at the end of the wharf. You can go online and read the daily weather readings along with wind and tidal information.

In 2017 became part of the marine component of Trans Canada Trails.

They are also part of NS Trails; and received funding from Develop NS for their placemaking initiative. These funds will be used for signage, boat launch and washroom upgrades.

The wharf is beside a protected beach and picnic area, and they are always working to ensure the public are making use of this space.

Up until a few months ago, the wharf brought in no revenue but now it is shipping some aggregate offshore.

The group also promotes wellness days, foot clinics, yoga and local hikes and it is all volunteers, there is no staff.

They would like to insulate the building at the wharf and put heat pumps in and we will be requesting some funding from Council for that at a later date.

They envision the same thing that is happening in the Ingonish area, there is economic potential in the Iona area.

The Economic Development Officers have not paid much attention to Iona over the years, and we would like Council to keep this in mind when a new EDO is hired.

Pioneer Cemetery in Washabuck is washing away into the Bras d'Or Lake. About 35 people are buried there, not owned by any church and the ones that are buried there were presbyterian. The owners of the land deeded that section of property to the local community centre and the community centre would like to put some armour stone in that area but are having a hard time finding funding for that. It would approximately cost \$25,000 so please pass that along to anyone that you think that could assist with that.

Councillors all thanked Mr. MacLean for coming and presenting to Council. Councillor Longva agreed that it is a very underdeveloped area, and we all benefit from the Highland Village being there.

Acting CAO Redden mentioned our grant application will be out in January and wanted to point out that the files all stay with the Partnership so when a new EDO is hired those files will stay with them. And there is provincial funding for cemeteries as well.

Warden agreed with the potential in this area as well.

Councillor MacNeil thanked Mr. MacLean and the Ventures for promoting economic development in the area.

HIGHLAND VILLAGE PRESENTAION – RODNEY CHAISSON

Councillor Longva confirmed if the Highland Village will be open year-round, and Mr. Chaisson said that only the main building will be open year-round for programing.

Councillor Patterson congratulated and thanked Mr. Chaisson for providing a great spot and experience.

Councillor MacDonald mentioned that this is his first visit to the Highland Village and asked what the best initiative for fundraising was. Mr. Chaisson said that they engaged with RVR Promotions to help with their fundraising campaigns but then Covid happened so all their fundraising campaigns were all done through Zoom. They were able to make connections with people who understood the importance of the Gaelic culture.

Councillor MacLeod asked if the Highland Village will be reaching out to the hotels so they will inform their guests of this experience. Mr. Chiasson said they are always trying to find ways to get the word out.

Councillor MacNeil thanked Mr. Chaisson for all the hard work he and his staff have done over the years. The Highland Village employs 46 local people so its very important for the area and Victoria County.

Warden Morrison recognized the potential for this area and said that this is a great investment, and it was well supported. Warden Morrison acknowledged that Mr. Chaisson was a recipient of the Queen's Jubilee Medal and congratulated him.

- Municipal Boundary Review community sessions held November 17 (New Haven AM / Baddeck PM), will be submitting to the UARB in December
- Minimum planning standards required due end of 2022; have requested an extension to end of 2023 as we are halfway through planning document

Tourism and Recreation

Tourism:

- Attended the CBU World Tourism Institute workshops on Reimagining the Tourism Workforce Nov 8&9
- TIANS Tourism Summit Coming up on Nov 29 & 30. It will be the first in person conference since 2019.
- Hosted our first Ingonish STEP (Sustainable Tourism Expansion Program) steering committee
 meeting in Ingonish with local community representatives, ACOA, Tourism Atlantic, Nova
 Scotia Tourism, and Destination Cape Breton.
- Upcoming Program with Tourism NS on Compelling Tourism Communities: Emerging Winter Destination Pilot Program for Ingonish.

Recreation:

- Attended the PAPE (Physical Activity Provincial Education) meetings last week discussing common interests and trends in Physical Activity Education initiatives.
- Working on a Dynamic Trail Workout pilot project that could be rolled out to many trails in the County
- Working on a multi-sport Pilot program for potential launch across all of the county in future years.

Community Development:

- Dingwall placemaking location project from 2022 has been completed with a new basketball
 court re-surfacing, new amenities in a picnic shelter, walking track, and solar lighting as well
 as waste bins. Next steps for the site will be to work towards securing funding and design
 concepts on a playground for the area and community events and gatherings on site next
 summer.
- SABDA St. Ann's Bay Development Association hosted an open house for the new
 "Gathering Place" placemaking project space at North Shore and District Firehall in Indian
 Brook
- Ross Ferry Stewardship Society Placemaking & Beautification project has begun and should be completed before next summer with enhanced parking areas, a new garden area and a freshening up of the site, signage and amenities on the site.

Trails:

- Have been meeting with Snowmobile clubs in preparation for the upcoming season and digging into their challenges for the upcoming season. Much work being done right now by volunteers to get things open and safe after hurricane Fiona and things are looking good for some needed bridge upgrades in a few areas also.
- No information yet received on the large Infrastructure Canada Grant for trails from March of 2022.

Finance

- Tax sale Nov 22: very successful 33 properties originally advertised, 6 deferred to future sale, 10 paid prior to sale, 17 available at tax sale - 15 sold, 2 not sold. For properties sold, collected over \$35k in outstanding taxes + \$150k in surplus
- Tax update: As of Nov 22, \$1.318m outstanding total this year (\$1.02m current, \$298k arrears)
 vs. \$1.475m (\$1.016m current, \$459k arrears) outstanding last year. Perspective on arrears amount outstanding:
 - o Nov 22, 2019 \$675k
 - o Nov 22, 2020 \$655k
 - o Nov 22, 2021 \$459k

Public Works

- Attended an online meeting with CAO MacEachen and Warden Morrison regarding the proposed C&D regulations, we are not in agreeance and will be submitting our concerns to the Department of Environment by December 9th, 2022.
- Baddeck Warehouse renovations are complete.
- Post Fiona C&D haul was completed November 17, 2022, we collected 382 metric tonnes.

- We will have to haul the brush, C&D and the shingles out of the Dingwall site in the very near future this will be at a significant cost.
- Scrap metal recycling is finished up at both sites.
- The new sideloader could be here by the end of March.
- Reached out to truck rental/leasing company in Ontario, not a long-term solution but in the short-term it could work if we needed that option.
- Asset management preliminary meeting scheduled for capturing our buildings/components at all our sites.
- Repairs to the old school in Ingonish starting Monday. There was damage to the roof from Hurricane Fiona.
- Attended a sustainable communities meeting. The next round of funding starts in the spring of 2023, might be a good thing for all departments to look at.
- EPR meeting on December 6th for printed paper and packaging for municipalities.
- Department of Environment was supposed to perform a site inspection of Neil's Harbour, the first time since the new technology has been in, now will be coming December 6th and will be issuing our new operating approval
- Investigating well pump issues in Ingonish.
- Trucked and disposed of approximately 50 lobster traps from Lighthouse Rd. in NH to Baddeck. This material was collected by Coastal Action, who was in the area collecting ghost gear that washed ashore during Fiona. Will collect the remainder this week.

Seniors Safety

- Submitted Age Friendly Communities grant for project called "Municipal Assets Resource Map" requesting \$25k to hire marketing and communications company to map local resources and create a database for use in-house and possibly a front-facing resource that would be publicly searchable
- Submitted New Horizons for Seniors grant for project called "Seniors Cook at the Food Hub" requesting \$25k to rent The Food Hub commercial kitchen for facilitated cooking classes
- Reporting due for Community Connections Micro Grant called "FAP awareness" \$1k to cover printing costs for a Victoria County Transit flyer with info about fare increase and FAP resource
- ACTing Collectively Project now underway and currently recruiting anyone over 65 to participate in a survey about needs. Please have anyone who might be willing to participate contact Cassandra or Keegan
- Working with RCMP on a tour of presentations in every district to offer information about Frauds and Scams to seniors
- Accessibility Committee will meet Dec 1 to review drafted Accessibility Plan

District 1

- Flooding in St. Columba due to beavers.

Councillor MacNeil said he received a number of phone calls about water bills, late charges people didn't know about, water bills being incorrect and requested that some check and balances be completed before water bills go out.

Councillor MacNeil said washrooms were mentioned in Mr. MacLean's presentation and asked if there was any more municipal support funds available for washrooms in the County. Acting CAO Redden said she will get back to Councillor MacNeil on this.

District 4

Councillor Longva said that there was a grand opening of "The Gathering Place" in North River. Councillor Longva congratulated Mary Ann Wilson and all the other folks who contributed in any way, it is a beautiful and welcoming place. There is sheltered sitting areas, so it can be used in inclement weather too. Thank you to our MLA Keith Bain for coming to help celebrate the opening. This was funded in part by Victoria County under the placemaking initiative. Thank you to Victoria County and ACOA for their contribution.

Councillor Longva asked if staff could look into the SCCF Sustainable Communities Challenge Fund which was created to avoid/reduce greenhouse gas and emission reduction. The non-refundable funds available are between \$75,000 and \$110,000. It's available to non-profit organizations and requires 20-40% contribution and 10 % in kind.
