In addition to waste collection services to residents, department staff operate two waste management facilities; Baddeck and Cape North. These are two recycling facilities, a ReUse Centre in Baddeck for gently used items, and two Enviro Depots located in Baddeck and New Haven. The Enviro Depots offer refundable recycling services and are paint and electronics drop-off centres.

Victoria County Water Utility:



More than 500 water customers have access to clean, safe drinking water. The Utility operates four water supplies servicing residents in the communities of Dingwall, Ingonish, Little Narrows and Neil's Harbour.

Field staff repair existing piping and valves, maintain fire hydrants, install water services, water main services, transmission mains, keep storage facilities and pump facilities plus are responsible for water metering and billing.

Victoria County Tax Rates 2022 – 2023

Residential – \$1.22 per \$100 assessment

Commercial – \$2.12 per \$100 assessment

Resource Property - \$1.22 per \$100 assessment

Taxation fiscal year is April 1, 2022 – March 31, 2023

Property taxes are due August 1, 2023

The main source of revenue (about 75%) for the municipality comes from resident's property taxes. Property Taxes are calculated using the taxable assessed value of a property, times the municipal tax rate (residential or commercial).

In Nova Scotia, properties are assessed by an independent, non-profit organization Property Valuation Services Corporation (PVSC). Every January, PVSC gives the municipality an assessment roll which is used to calculate resident's property taxes.



Victoria County Property Programs:

Nova Scotia Property Tax Rebate for Seniors – seniors receiving the Guaranteed Income Supplement (GIS) may be eligible for a property tax rebate. This rebate is through the provincial government, but our tax department staff are knowledgeable (902-295-3231).

Municipal Tax Exemption (low income) – if your household taxable income is less than \$35,000 a year, you may be eligible for a tax exemption.

Property Assessed Clean Energy Program (PACE) – Homeowners can apply to municipality's Clean Energy Financing program to help finance home energy upgrades at a lower interest rate.

Victoria County Property Programs:

Water Supply/Septic Upgrade Lending Program – this program helps residents access low interest financing to complete a water supply or septic upgrade for their property. The program operates on a first come, first serve basis until its' budget for the fiscal year has been allocated.



Building Permits & Inspections



David MacKenzie

The Eastern District Planning Commission (EDPC) oversees the planning, subdivision and building inspection services in eastern Nova Scotia, including Victoria County.

It is a legal requirement to obtain a building permit for all construction projects. This applies to any construction building project; from a new home to large shopping mall renovations.

David MacKenzie is the EDPC Building and Fire Inspector for the County of Victoria.

As inspector, he will review building plans and ensure they meet all applicable National Building Code Requirements, conducts on-site inspections at various stages of the construction project to ensure building standards are met.

Residential construction value is determined using an annual Altus Group Canadian Cost Guild or the contracted price of construction. The 2022 Construction cost is \$260.00 per square foot.

Emergency Services

Victoria County Emergency Management Officer (EMO) is responsible for emergency planning, coordinating emergency responses, as well as raising awareness of emergency preparedness for residents and business.

Our municipality relies on volunteer firefighters throughout the County to help keep our residents safe.

there is a Trails Development Support program to financially support new development, trail maintenance/repair or marketing.








VCT can be used for appointments, getting to work or hospital visits.

Q: Who is responsible for maintenance of highways and roads?

A: The Nova Scotia Department of Public Works is responsible for building and maintaining highways, roads and bridges which includes plowing, paving, patching, grading, and clearing ditches.

Q: How do I pay my property/water taxes?

A: For all municipal residents of Victoria County, except Village of Baddeck residents, property and water taxes are paid once a year and are paid to the municipality.

For residents of the Village of Baddeck, property taxes, sewer and water services are provided by the Village of Baddeck, not Victoria County.

Q: Does the municipality update my new address?

A: You are responsible for ensuring your address is correct. Please let us know if you move so we can update your civic address and postal information. You can either email at info@victoriacounty.ca or call 902-295-3231

Q: Can I get a municipal form/application/document in print?

A: Yes. Please drop by the Municipal Office (old Courthouse) located at 495 Chebucto Street in Baddeck during business hours (Monday to Friday 8:30 am - 4:30 pm) If you need a municipal document printed, please drop by.
