CAO MacEachen went over the Warden and Deputy Warden election process and 5 minutes was given to each nominee to present their platforms for election of Warden and Deputy Warden.

ELECTION OF WARDEN

Councillor Kerr nominated Councillor MacLeod Councillor Patterson nominated Councillor Born.

Councillor Hennick nominated Councillor Organ.

Councillor Organ had 4 votes.

Councillor MacLeod had 2 votes.

Councillor Born had 2 votes.

With 4 votes, Councillor Organ was elected Warden for a 2-year term.

ELECTION OF DEPUTY WARDEN

Councillor Matheson-Lefort nominated Councillor MacLeod

Councillor Born nominated Councillor Patterson.

Councillor MacLeod had 4 votes.

Councillor Patterson had 4 votes.

Each name was written on a separate ballot and placed into a box for the name to be drawn by lot.

Councillor MacLeod's name was pulled from the box, electing her as Deputy Warden for a 2year term.

On Motion of Councillor Donovan seconded by Councillor Patterson to allow CAO MacEachen and Ms. MacLeod, to be appointed scrutineers for the Warden and Deputy Warden election.

Motion Carried.



On Motion of Councillor Kerr, seconded by Councillor Donovan that the ballots be destroyed.

Motion Carried.
